In that role, he provides the governor with nominees for appointment to Florida's Fourth District Court of Appeal, which hears appeals arising out of Palm Beach, Broward, St. Lucie, Martin, Indian River, and Okeechobee Counties.

Jason also serves as the Second Vice Chair of the Business Litigation Committee of the Florida Bar.
