He graduated summa cum laude from Harvard Law School, following a Fulbright Fellowship in Gwangju, South Korea, and with distinction from Amherst College, where he studied Economics and Political Science and was President of the student government.

Mr. Dubinsky joined Boies, Schiller and Flexner in December of 2014, following a clerkship with Justice Anthony M. Kennedy. Before his Supreme Court clerkship, he clerked for Judge Brett Kavanaugh of the U.S. Court of Appeals for the D.C. Circuit and Judge Gary Feinerman of the U.S. District Court for the Northern District of Illinois. Mr. Dubinsky is a graduate of Yale Law School, where he served as Executive Editor of the Yale Law Journal and Articles Editor of the Yale Journal of International Law, and worked as student director at the Yale Supreme Court Advocacy Clinic. As part of his work with the Clinic, Mr. Dubinsky helped write several merits and certiorari briefs

before the Supreme Court. While in law school, he spent a summer in Kosovo working for the legal unit of the International Civilian Office, a joint United States-European Union organization that oversaw Kosovo's democratic development. From 2007 to 2008, before starting at Yale Law, Mr. Dubinsky worked as a junior fellow at the Carnegie Endowment for International Peace. He received his bachelor's degree from Wesleyan University, where he was editor-in-chief of the student newspaper.
